UNUSUAL FIRE AND EXPLOSION HAZARDS

PRECAUTIONS TO BE TAKEN IN USE

Use only with adequate ventilation. Avoid contact with skin and eyes. Avoid breathing vapor and spray mist. Wash hands after using.
