### Environmental precautions

### Methods and materials for containment and cleaning up

#### Small spill

Stop leak if without risk. Move containers from spill area. Absorb with an inert material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

#### Large spill

Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. ## Section 7. Handling and storage

### Precautions for safe handling

#### Protective measures

Empty containers retain product residue and can be hazardous. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. #### Advice on general occupational hygiene

#### Conditions for safe storage, including any incompatibilities

Store in accordance with local regulations. Keep container tightly closed and sealed until ready for use. Store and use only in equipment/containers designed for use with this product.
